The City of Emporia will accept sealed bids for the purchase of petroleum products. For estimate purposes, it is anticipated that the following quantities for each product will be required during fiscal year, July 1, 2015 – June 30, 2016. *These are estimates only.*

Gasoline/Fleet Card System

87 Octane	Regular Unleaded	10,000 Gallons
89 Octane	Mid-Grade	50,000 Gallons
93 Octane	Super Unleaded	5,000 Gallons

L. P. Gas

Quantity Estimate –15,000 Gallons

Note: L.P. gas delivery sites are as follows: Fire Department’s emergency generator at Valley Street, Municipal Building at 201 South Main Street and City Shop at 1921 Sunnyside Road.

Fuel Oil (Diesel)/Fleet Card System

Note: Diesel fuel supplier (Fleet Card System) must be able to provide fuel for city equipment (backhoes, street sweeper, tractors, etc). No further than ½ miles from where the equipment is based, rear of Police Department.

Note: Bulk oil supplier to furnish and install bulk 275 gallons storage tanks, piping, hose reel dispenser unit for each petroleum product (4 each).
